

# Student Parking Permit

## Parking Rules and Regulations Modesto High School

1. All vehicles must be registered with the Supervision Office and the Modesto High School parking permit must be visibly displayed in the front window on the mirror.
2. The student must possess a valid California Driver's license and proof of insurance.
3. The student and his parents or guardians must assume liability for damage to school property.
4. The school cannot be responsible for damage or loss to any vehicle brought to school.
5. Vehicles are to be parked and not used during the school day except when prior approval has been granted by the school.
6. The student must park in the prescribed parking area in the spaces designated for students. This includes motorized two-wheeled vehicles.
7. Tickets will be issued to those in violation of regulations by campus supervision.
8. Speeding and reckless driving will be penalized through campus supervision and parents will be contacted.
9. Repeat offenders may be towed at the owner's expense and/or incur a loss of school driving privileges.
10. Parking permits will need to be renewed every school year.
